•	Known as <u>Conservatives</u> they wanted the South to change
	as little as possible
•	Wealthy planters wanted to Force the freedmen back to work on
	plantations
•	Small farmers and laborers felt <u>threatened</u> and
	competed with <u>Freedmen</u> for land and power.

•	Secret <u>societies</u> formed to help white southerners regain
	power
•	Most dangerous "secret society" was the <u>Ku Klux Klan</u>
	or KKK
•	It worked to keep blacks and white <u>Republicans</u> out of
	public office
•	Members dressed in white to hide their identity
•	Rode at night to thehome5 of African Americans
•	Shouted <u>threats</u> and burned <u>wooden</u> crosses
•	If threats didn't work the Klan used
•	They murdered hundreds of African Americans and their white
	allies

•	Cotton production recovered <u>slowly</u>
•	By 1880, planters were growing as much cotton as they had in
•	Industry grew, but still lagged behind the rest of the nation

By the 1900, the south was producing a <u>5 maller</u> part of the
nation's manufactured <u>good5</u> than it had in 1860
• Reconstruction governments raised
 Many freedmen and poor <u>whites</u> went to work on large
plantations
 They farmed the planer's land and in return were given a <u>share</u> of
the crops at harvest
 These <u>land/ess</u> farmers were called sharecroppers

 By 1866 most states had ratified the 13 Amendment (hanned slavery)
 White Southerners did not want to give African American "real
Freedom "
• Legislatures passed <u>Black</u> <u>Codes</u>
-Laws that severely <u>limited</u> the rights of freedmen
Black Codes
 Forbade African Americans to <u>vote</u>, own <u>guns</u> and serve
on <u>Juries</u>
 Permitted them to work only as <u>Servants</u> or farm laborers
 They did get some <u>rights</u>. They were allowed to legally

Republicans were angered by the black codes and election of former
Confederate leaders to Congress
Republicans sent a report <u>condemning</u> these things to
President Johnson - He <u>Ignored</u> it
Members of Congress vowed to take Reconstruction out
of the President's hands
Radical Republicans or simply Radicals
 Led the <u>opposition</u> to President Johnson
• 2 <u>main</u> goals

1. to break the power of the Planters who had ruled
the <u>5outh</u> for years
2. to make sure <u>Freedmen</u> received the right to
<u>vote</u>
In April 1866, Congress passed the <u>Civi</u> Rights Act, this gave
<u>Citizenship</u> to African Americans
 President Johnson <u>Vetoed</u> the bill
Congress <u>overrode</u> the veto
Worried that the Supreme Court might declare it
unconstitutional, Republicans proposed the Amendment
14 th Amendment
 Granted citizenship to all <u>person s</u> born in the U.S. (this
included African Americans)
Guaranteed all citizens "equal <u>profection</u> of the laws"
 Declared no <u>5+a+e</u> could "deprive any person of life, liberty, or
property without <u>due</u> <u>process</u> of law"
 Made it illegal for states to <u>discriminate</u> against an
individual on "unreasonable <u>grounds</u> " such as the color of the
person's skin
President Johnson opposed the Amendment
Urged all former Confederate states toreject it. All did except
Tennessee
 It became an issue in the November/866 Congressional elections
 Results were a <u>disaster</u> for Johnson – Republicans won
majorities in both <u>Houses</u> of Congress
Congress could nowoverride President Johnson's vetoes
Radical Reconstruction
 The period that followed the <u>election</u> of 1866
 Congress passed the 1st Reconstruction Act over
President Johnson's veto

This Act:
1. Threw out the southern governments that had <u>refused</u> to
ratify the 14 th Amendment
2. Divided the South into 5 "ifi fary districts" each
commanded by an army <u>general</u>
3. Required the former Confederate states to write new
constitutions
4. Required the new state governments to ratify the/4 Amendment before
<u>rejoining</u> the Union
5. (and most importantly) stated that African American must be allowed to
<u>Vote</u> in all southern states
In the elections that followed, <u>Freedmen</u> turned out to exercise their
right to vote. Republicans gained <u>Control</u> of
southern state governments.
Afraid the Johnson would not <u>enforce</u> these laws, Republicans
decided to remove him from office
 February 24, 1868, the House of Representatives voted to <u>Im peach</u>
Johnson
 Constitution states that a President may be impeached for "high <u>Crimes</u>
and misdemeanors"
The case is tried in the <u>Senate</u>
 President is <u>removed</u> from office only if found <u>quilty</u>
by 2/3 of the Senators
 Vote was 35-19. One vote <u>short</u> of the 2/3 to remove Johnson from
office.
Ulysses S. Grant
 In 1868 Grant runs for <u>President</u> and easily wins
 In 1869 Congress proposes the/5 4h Amendment
- It forbade any state from <u>denying</u> African Americans the
right to vote because of their race

•	Tilden won the vote, but was 1 vote short of the 182
	electoral votes needed to win
•	electoral votes were in dispute
•	Congress set up a special <u>committee</u> to settle the crisis
•	The committee gave all the <u>disputed</u> votes to <u>Hayes</u> .
	He wins the election.
•	Hayes had agreed to <u>end</u> Reconstruction
•	He removed all remaining federal from South Carolina,
	Florida and Louisiana
•	Reconstruction is Over
•	By the late 1880, many southern states passed taxes. This
	required voters to pay a <u>Fee</u> each time they voted
•	Poor <u>Freedmen</u> could not afford to pay the poll tax, so they
	could not vote
•	Literacy test required voters to read and explain a difficult part of
	the Constitution. Freedmen had little <u>education</u> so these
	tests kept them away from the polls
•	Some southern whites were and illiterate (not able to read o
	write). To allow them to \sqrt{ofe} , states passed grandfather clauses.

•	If a voter's father or <u>grand father</u> had been eligible to vote
	on January 1, 1867, the voter did <u>not</u> have to take a literacy test
•	Since African Americans in the South could vote before 1868,
	grandfather clauses were a way to ensure only whitemen could vote.
