The Presidents of the 1960s=



Dwight D. Eisenhower 1953-1961

- 1. In World War II he was Supreme Commander of Allied Forces.
- 2. During his campaign for President, Eisenhower swore to end the Korean War. He did so in 1953.
- 3. He appointed Earl Warren, a moderate, as the new Chief Justice of the Supreme Court.
- 4. On November 6, 1956, Eisenhower scored a landslide victory over Democratic opponent Adlai E. Stevenson and was reelected President.
- 5. He continued the struggle to integrate America's schools.
- 6. He sent five thousand marines to Beirut, Lebanon, to help preserve that country's government.
- 7. During his presidency, construction was begun on the nation's interstate highway system.

John F. Kennedy 1961-1963

- 1. During World War II he became a hero when a Japanese destroyer cut his PT boat in two, and he saved his crew from drowning.
- 2. In 1946 he was elected as a congressman from Massachusetts:
- 3. In 1952 he ran for the Senate and won by an overwhelming margin.
- 4. During his first Senate term, he wrote a book, *Profiles in Courage*, for which he was awarded the Pulitzer Prize.
- 5. The space program was one of his top priorities, and he promised that America would put a man on the moon by the end of the 1960s.
- 6. His New Frontier program was to help the elderly, the young, and those being deprived of their civil rights.
- 7. He created the Peace Corps in order that America might aid impoverished countries.

- 4. Several of our Presidents were in the military before becoming President. Do you think military experience is important in order to be a good President?
- 5. Most of our Presidents have been career politicians. Does a politician make a good President?
- 6. What three jobs should be on a person's resume before he/she can be considered for the presidency?

The Presidents of the 1960s=



Lyndon Baines Johnson 1963-1969

- 1. At the age of twenty-nine, he won election to Congress. He represented Texas.
- 2. He was elected to the Senate in 1948.
- 3. In 1955 he became Senate Majority Leader. He was a politician who could "get things done."
- 4. Under his administration there was more civil rights legislation passed than ever before, including the Civil Rights Act in 1964.
- 5. He created both Head Start and Job Corps.
- 6. The Voting Rights Act he engineered outlawed literacy tests that kept African Americans from voting.
- 7. He guided Congress into passing Medicare, a federal health bill for the elderly.
- 8. In his inaugural address he declared a "War on Poverty."
- 9. He was powerful and shrewd and was able to get Democrats and Republicans to cooperate.

Richard M. Nixon 1969-1974

- 1. He served in the Navy during World War II.
- 2. Before he was elected as a congressman from California, he was a lawyer.
- 3. In 1950 he was elected to the Senate.
- 4. He became Vice President in 1952 and was reelected in 1956.
- 5. He was elected President in 1968.
- 6. As President, he ended United States military participation in the Vietnam War in 1973.
- 7. He eased the tension that had existed for years between the United States and both the Soviet Union and China.
- 8. He helped create a U.S./Soviet agreement to limit nuclear weapons.
- 9. He ended the military draft and created an all-volunteer system for our armed forces.
- 10. As President he was respected for how he handled foreign policy.
