REQUIRED RESIDENCY DOCUMENTS

AFFIDAVIT OF RESIDENCY: District Resident must provide one item from Category I and three items from Category II, person enrolling student must provide three items from Category II. Affidavit forms must be signed and notarized. Please refer to the list of examples to show proof of residency.

CATEGORY I

(One of the following specific documents are required- NO SUBSTITUTES.)

Examples:

- Most recent property tax bill
- Most recent mortgage statement (coupon books are not accepted)
- Signed and dated lease with last month's payment, e.g. cancelled check or renter's receipt.
- Mortgage Settlement/ HUD statement from closing if have within 30 days.
- **Affidavit of Residency: When the person seeking to enroll has a student living with a District resident, the District resident needs to complete the Affidavit form Part II and show proof of residency from Category I and Category II. The student's family needs to complete the Affidavit form Part I and show proof of residency from Category II. (Affidavit forms must be signed and notarized.)**

CATEGORY II

(Three documents showing property address are required)

Examples:

- Currents driver's license
- ☐ Current vehicle registration
- ☐ Most recent cable television bill (must show service address)
- ☐ Most recent gas, most recent electric, and/ or water bill (must show service address)
- ☐ Current public aid card
- ☐ Current bank statement
- Current homeowner's/ renter's insurance policy with premium payment receipt
- ☐ Current paystub
- ☐ Receipt for moving van rental
- ☐ Voter registration card
